

How are we making a difference?

Global attention is increasingly focused on our food and land use systems. Agribusinesses represent over \$5 trillion¹ in global trade and support the livelihoods of 2.5 billion² people. Agriculture has also been clearly linked with the world’s unprecedented challenges: addressing climate change and biodiversity loss whilst providing food and resources for a growing population.

It is essential that those with greatest exposure and influence operating closest to the farmgate are positioned to inform emerging regulation and new sourcing requirements.

The Global Agribusiness Alliance (GAA) is a multi-commodity and cross-geography CEO-led platform for supply-side advocacy and action. Its mandate is to advocate for the positive role of agribusiness in society by designing and demonstrating positive solutions to our shared challenges.

GAA focuses on four areas:

- sustainable landscapes
- rural livelihoods
- water stewardship
- food loss – resource efficiency.

We partner with a number of groups including the World Resources Institute, IUCN, EcoAgriculture Partners, Fauna and Flora International, the Alliance for Water Stewardship. Achievements to-date include:

Share and scale our contribution to the SDGs

The United Nations (UN) SDGs are a common framework and universal plan of action for equitable, socially inclusive and environmentally sustainable economic development. 193 UN member states adopted the 17 goals adopted in 2015 that aim to end poverty, protect the environment and promote prosperity by 2030.
